- c. Members will not be required to identify themselves as a member of the North Melbourne Football Club at the time of purchase of the vehicle.





Stage 2: Claiming the Mazda Kangaroos Offer

- Following purchase and registration of the vehicle, download the Mazda Kangaroos Offer claim form available on the North Melbourne Football Club website at <u>https://membership.nmfc.com.au/member-benefits/mazda-member-offer</u>
- b. To claim the Mazda Kangaroos Offer, the purchaser must email the completed and signed claim form to Mazda at the address set out on the claim form, together with:
 - I. A copy of the registration papers of the vehicle purchased.
 - II. A copy of the sale contract for the purchase of the vehicle.
 - III. A copy of the Kangaroos membership card (if known)
- C. Mazda will not be responsible for any claim forms that are lost in the mail, during transmission or are received by Mazda illegible or damaged.
- d. The claim form must be received by Mazda within <u>6 months</u> of the date of purchase of the vehicle. Mazda will not accept any claims or apply the Mazda NMFC Offer if the claim form is received at Mazda after the 6-month period.
- e. Upon receipt of the claim form, Mazda will verify the identity of the member and whether they comply with these terms and conditions at the time of purchase and delivery of the vehicle.
- f. Upon verification of identity and appropriate documentation Mazda will send the special package and provide the North Melbourne Football Club with the Member's details to apply the additional one (1) year North Melbourne Football Club membership or merchandise pack.
- g. Mazda reserves all rights to refuse or reject any claims for the Mazda Kangaroos Offer if Mazda in its discretion determines or is of the reasonable opinion that the claimant does not meet or comply with these terms and conditions.

7. Incomprehensible and illegible claim forms and accompanying documents will be deemed invalid.

8. Mazda reserves the right to request claimant to provide Mazda with any additional proof of identity, proof of purchase of a vehicle or other evidence. Mazda requires to establish the validity of the claimant's Mazda Kangaroos Offer claim, and to reject any claim for the Mazda Kangaroos Offer if the claimant is unable to satisfy any such requests to the extent Mazda requires in its discretion.
